

Key to Wyn Official Rules

1. Eligibility: Key to Wyn (the "Promotion") consists of a sweepstakes (the "Sweepstakes"), an online instant win game (the "Instant Win Game"), as well as a tap instant win game (the "Tap Instant Win Game").
